• FWSA Recruitment Report Fall 2019/Spring 2020

A total of 112 inquiries from experienced prospective new players were received for both the Fall (80) & Spring (32) season. Of the 112, 65 were in the Open Div. age range and of these 29 registered for a team. Of the 112, 37 were in the Masters- and-up age range and 15 registered for a team. Additionally, there were 22 players interested in Developmental Div.

Summary of FWSA 2019-20 Board Activity

> 2019 June Board Meeting - Transition to new board

Continue sub pool trial in Fall for case-by-case agreement with both team reps and DC approval for additional subs above three (3). Only allow a max of 11 players if more than 3 subs requested/allowed. If trial seems reasonable during the Fall, board can vote for permanent inclusion into Rules. Guidance to go out in email for Fall season.

> 2019 August Team Rep and Board Meeting

- Suzanne Samuels voted to assume Fields position for Audrey Reil who is moving out of the area.
- Approval of name change for Webmistress position to "IT Support". Approved by Board to be submitted to amend Bylaws by vote at General Assembly meeting.

> 2019 November Board Meeting

- Board agrees to keep past Demosphere registrations for reference through 2020.
- Gold league (58+) fees and games Fee adjustment in Spring: \$45 per player includes one ref, 10 games per season at 60 min./game and still has out of county fee
- Developmental fees remain the same for this group.
- Sub Team rescinding sub request after sub has accepted if notified with reasonable amount of time (24 hours was suggested) is allowed.

> 2020 February Board Meeting including dinner

- FWSA new merchandise store through Cheer Sports board agree to forego profit to ease delivery fees. Limiting selection for launch to keep offerings simple.
- Discussion on Bylaw and Rules Changes. Bylaws changes to be prepared for May vote. Rules discussed and changes tabled for a later date.
- Agreement to retire use of yellow sub cards and send soft copy of Team Rep Duties and Sub Pool Guidelines.

> 2020 March Team Rep and Board Meeting

• Agreement to waive 14-player roster requirement for Open Division and extend Spring registration by one week.

> 2020 March 15th Spring League Notice Sent

 Suspending all games and activities until further notice from the county due to COVID-19 pandemic concerns.

2020 March Emergency Board Meeting – emergency meeting due to COVID-19 pandemic

- Due to recent developments, board cancels Spring season with intent to move fees to the Fall season unless notified by individuals.
- Depending on when field permits are granted again, may pull summer session forward or establish "meet & greet" games.
